- 2. Purpose of processing:

The photos and/or videos are used exclusively for the public relations of the CECAD Cluster of Excellence.

3. Legal basis for processing:

The processing of photos and/or videos (collection, storage and transfer to third parties, see under 5.) is based on the express consent of the person(s) with parental authority or the person(s) concerned, thus in accordance with Art. 6 para. 1 letter a DSGVO. The publication of selected image files in (print) publications of the organizer(s) as well as on their homepage/Facebook account or similar is necessary for the public relations work of the organizer(s) and thus serves the legitimate interests of the parties involved, Art. 6 (1) letter f DSGVO.

4. Categories of recipients of the personal data:

The photos and/or videos will only be passed on to third parties (other PR areas) in the context of PR measures for public relations purposes, they may be posted on the homepage of the CECAD Cluster of Excellence and its partner institutions (MPI Age, MPI SF, DZNE) and used for the Facebook page of the association.

5. Duration of storage of personal data:

Photos and/or videos, which are taken for the purposes of public relations, are stored for an indefinite period of time for a specific purpose, subject to revocation of the consent of the person(s) concerned.

6. Right of withdrawal in case of consent:

Consent to the processing of photos and/or videos can be revoked at any time for the future. The legality of the data processing carried out on the basis of the consent until the revocation is not affected by this.

- 7. Data subject rights
 According to the General Data Protection Regulation, you have the following rights:
- a) If their personal data is processed, they have the right to obtain information about the data stored about them. (Art. 15 DSGVO)
- b) If incorrect personal data is processed, you have a right to rectification (Art. 16 DSGVO)
- c) If the legal requirements are met, you can request the deletion or restriction of processing, as well as object to processing (Art. 17, 18, 21 DSGVO)
- d) If you have consented to the data processing or if a contract for data processing exists and the data processing is carried out with the help of automated procedures, you may have a right to data portability. (Art. 20 DSGVO) If you make use of the aforementioned rights, the person responsible will check whether the legal requirements for this are met. Furthermore, you have the right to lodge a complaint with the State Commissioner for Data Protection of the State of Brandenburg.
